I practise in Priory Hospital Bristol, and in London.

I am visiting consultant to a special needs school, in Devon, which has students with EBD, ASD, ADHD and challenging behaviour.

I am visiting consultant to residential homes that cater for people with Asperger's and have legal restrictions.

I was working for the NHS, as a Consultant Psychiatrist in Complex health needs service (till Nov 2016). This was a community learning disability service in Bath.

I was the Lead Clinician for The Hayes, an independent hospital for people with Asperger's Disorder and detained under the MHA (1983), managed by the National Autistic Society, with responsibility for patients with severe Asperger's Syndrome and those with severe mental illness and co morbid borderline learning disability in low and medium-secure settings.

Borderline to mild Learning disability and Probation, Courts, Mental disordered patients in the criminal justice system, Fitness to plead/Effective participation in Court process, fitness to instruct Legal representatives.
